#### Who can join?

Any teacher, principal, assistant teacher, VET lecturer, trade trainer or classroom support staff member working in NT public education is eligible to join the AEU.

# **6 REASONS TO JOIN THE AEU NT**

#### **BE PART OF SOMETHING IMPORTANT**

A union is a collective group of members that undertake the same type of work. Unions are member-led organisations, representing members when it comes to bargaining for pay rises, work entitlements and conditions of employment. Without unions, we would have no paid parental leave, superannuation, Medicare, workers compensation, work health and safety laws, paid annual leave or even the weekend! The AEU has 2000 members in every school and public education facility in the NT and, with more than 190,000 members nation-wide, the AEU has the collective power to uphold the wage increases and job entitlements that all educators now enjoy.

#### **ADVICE, REPRESENTATION AND PROTECTION**

Union membership protects you at work. If something crops up at work, whether it be an accident, allegations of underperformance or breach of discipline, bullying, underpayment, redundancy or anything else, the AEU can assist. As a member, you will never be alone in meetings with management or forced to deal with complex issues on your own. Our staff are experts in industrial legislation, negotiation and advocacy. You simply won't find this level of experience and expertise anywhere outside of the AEU.

#### **5 PAID DAYS LEAVE TO ATTEND TRAINING**

As an AEU NT member, you are entitled to up to five days of paid leave each calendar year to attend union training courses. These training days count towards your normal service and professional development.

#### ACCESS TO LEGAL ASSISTANCE

For existing members, the union provides access to professional lawyers for any private legal matter, or any matter that occurs in your employment that our industrial officers are unable to assist with. After an initial free consultation, you may be eligible for legal assistance funded by the union.

#### HELP SUPPORT A ROBUST AND WELL-FUNDED PUBLIC EDUCATION SYSTEM IN THE NT

Your membership enables our union to ensure that schools, universities and other government education services are able to deliver quality education to students across the NT. We need your membership to address issues like large class sizes, unrealistic workloads, job security and the safety of staff and students. Union-run campaigns improve working conditions and school resourcing, ensuring politicians and the wider community understand the issues facing educators.

#### YOUR UNION DUES ARE TAX DEDUCTIBLE

Our fees are set at less than 1% of your gross annual salary and start at \$13 a week for teachers. Your contributions are fully tax deductible and you will receive a statement at the end of the financial year for your tax return. Your dues make our work as a union possible, meaning we can employ a skilled and responsive team to deal with issues that you face individually and collectively.
