Only statements which comply with the Rules and are received by the Returning Officer by 5:00pm (Australian Central Standard Time (ACST)) on 21/08/2024 can be accepted. The Branch Secretary or other duly authorised Branch Officer shall be responsible for arranging for the publication of candidate statements.
